


From our President and CEO

It is my pleasure to present our 2019-20 Annual Report. We are proud of our continued focus on impact and outcomes in the communities we serve.

In March of 2020, the COVID-19 coronavirus launched our country -- and the entire world -- into a tailspin. Our team quickly came together to make sure that our focus of connecting and mobilizing resources remained intact. Generous donations totaling \$103,000 came in from several corporate sponsors including Meijer, Truist Foundation (formerly BB&T), First Financial Bank and LCNB National Bank. We were able to quickly leverage those donations to provide even further assistance through a collaboration established between Butler County United Way, Greater Cincinnati Foundation, Hamilton Community Foundation, United Way of Greater Cincinnati, United Way of Warren County, and Warren County Foundation. We were able to find matching dollars to increase the funds to over \$450,000. With this money, over 97,000 people were provided resources such as childcare, personal protective equipment (PPE), food and shelter. In the worst of times, it is truly rewarding to see our county and region rally together to help each other.

We have continued to focus on our three pillars of Education, Financial Stability, and Health. With your donations here are some of the amazing outcomes that were achieved through the Butler County United Way funded programs our partner agencies provided.

Education: Through our partnership with the Ohio Governor's Imagination Library, over 6,560 books were delivered to children focused on early childhood literacy. Over 3,000 home visits were completed that focused on child growth and development and 4,010 families were provided with educational resources, tools, and training. In addition, 29,125 bags of food were distributed to children for healthy living and support of academic success

• Financial Stability: Over 79,000 meals were distributed to feed the hungry and 515 military families were provided emergency services including shelter and medical supplies. Also, over 3,000 low income seniors and adults received personal finance management through financial literacy education and savings programs and 410 low income homeowners received home repair and modification service and mobility improvements.

 Health: 6,265 uninsured/under insured individuals received comprehensive health care services, 3,195 people in Butler County received preventive care support leading to healthier lives, and 11,260 people received crisis intervention and/or mental health counseling services.

We have continued to focus on volunteer efforts. While the virus slowed us down in the third quarter, we still logged 28,550 hours of volunteer service. Our CommUnity Connect volunteer portal continues to be a ready resource for those who wish to share their time and talents for the benefit of Butler County.

Our local funding is focused on collective impact going beyond single-issue solutions and temporary fixes. We continue to look at ways to organize across a broad group of organizations to help implement effective, meaningful, and sustainable change. And we are not alone. United Ways in more than 40 counties across the world have been applying the same concentration. Over the past three years, we have been contributing information to United Way Worldwide's Global Results Framework to track collective impact on a global basis. The results are impressive. United Ways collectively have invested \$318,121,676 into educational programming which has resulted in 708,011 children enrolled in high quality early childhood education classes and 644,649 receiving additional literacy support. In the health sector, over \$324,000,000 was invested resulting in 7,245,430 individuals in physical activity and/or food nutrition programs. In addition, 79% of youth or adults reduced risky behavior and 72% of babies had healthy birth outcomes. We are but one of 1,800 United Ways throughout the world. The combined efforts of all the United Ways working toward the same goals are truly having an impact on the world.

We all have a stake in what befalls our fellow man. We all benefit when a child succeeds in school, when someone finds a job that will help them provide for their family, or when more people are able to access quality, affordable health care. The solutions we create for our communities in Butler County go beyond short-term charity for a few. We envision a world where every community is a strong one, with jobs that pay a livable wage, good schools, and a healthy environment. Engaging people and organizations in innovative solutions is transforming that vision into reality.

It is with sadness and gratitude that this will be my final formal annual letter to the community. I have made the decision to retire in the first quarter of 2021. I have been passionate regarding the mission of Butler County United Way and will continue to volunteer throughout the region. I am leaving a very qualified and seasoned staff who will continue our mission and vision.

We rise or fall together. With your support, we will continue to reach for great new heights.



COVID-19 Regional Response Fund Distribution and Allocation Summary



Butler County United Way



Butler County United Way led the charge in partnering with the Hamilton Community Foundation, other regional United Ways, Community Foundations and generous corporate partners to create a COVID-19 Regional Recovery Fund. The Fund's intent was and is to assist Butler County non-profit organizations while helping to minimize duplication of services and maximize the value of available resources. The Fund allows ongoing assessment of emerging demand trends and provides the ability to pro-actively monitor and react to our county's needs.

The Butler County COVID-19 Regional Recovery Fund was directed through the Greater Cincinnati Foundation who provided \$150,000 in matching funds for Butler County nonprofit organizations. Initial funding was generously provided by Butler County United Way, First Financial Bank, Hamilton Community Foundation, Meijer, Truist Foundation, and United Way of Greater Cincinnati. A total of \$474,000 was distributed from the fund for Butler County COVID-19 relief.

The Fund addressed needs in our region related to the coronavirus pandemic, especially for those who were disproportionately affected. Funding focused on high-need populations that ended up in immediate financial crisis with any disruption. We targeted services that had the most impact on speeding up the human and economic recovery from COVID-19 such as food insecurity, medical needs, housing and shelter, and childcare and senior services, to name a few.


