Andrew Schnell (Vice President, The Cincinnati Insurance Companies) assumes the Board Chair role, following his term as Vice Chair. Marcia Andrew (Partner, Taft, Stettinius & Hollister, LLP) steps into the Vice Chair role, Mariann Penska (Retired LexisNexis) becomes Board Secretary while Kevin McKinney (Park National Bank continues in his role as Board Treasurer.

Butler County Board of Trustees Chair Andrew Schnell says he has high hopes for Butler County United Way's future with the new perspectives and experience Jackson, Jordan, and Chamberlain will add to the board. "I look forward to working with them as we continue to unite and maximize the community's resources so all can thrive," said Schnell.
