



COMMUNITY IMPACT

Having a positive impact on community needs is the goal set by the Butler County United Way Board of Trustees. With the dedicated assistance of more than 45 trained community volunteers, award decisions are made for youth and adult programs that will have the greatest impact, reduce duplication, and that work collaboratively with other programs to serve our community in the most effective ways possible. The volunteers also review the progress of programs throughout the year to ensure quality service provision and accountability to community donors.

YOUTH IMPACT AWARDS



\$89,000

Support for Success

Butler County youth will have supportive relationships that reduce risky behavior.

\$381,000

Growing Assets

Butler County youth will become successful adults through participation in programs that build developmental assets.

\$470,000

Butler County United Way is focused on assisting our youth to become successful adults.

Community surveys identified risky behaviors as the most critical threat to the well-being of our youth. In response, Butler County United Way has expanded youth funding to two areas to continue the wider scope of programs as well as the targeted area found in the surveys.

▲ **Support for Success:** Beginning July 2011, programs have been selected for funding in specific response to the need for all Butler County youth to have supportive adult relationships that reduce risky behaviors.

▲ **Growing Assets:** This ongoing funding category supports programs that increase developmental assets that build resiliency and lead to the success in adulthood. Services funded include early childhood, afterschool and extracurricular programs, as well as intervention programs that provide preventative training and support to youth and their families.

SELF SUFFICIENCY AWARDS

In 2010, in addition to funding programs that increased self-sufficiency of Butler County residents, a focused area of funding was established that targeted financial independence. In 2011, three areas of funding are addressing community needs as chosen by more than 2000 residents who participated in community surveys.

Pathways to Independence

Chronically unemployed or underemployed people will become employed and will retain their jobs so they can become self-sufficient.


Self-Sufficiency

People who experience a one-time crisis or have been struggling for years to make ends meet are receiving significant interventions, allowing them to reduce their dependence on social service programs and move toward self-sufficiency.

Basic Needs

Living in poverty may be a hardship people face every year. United Way supports people through programs that offer food and emergency assistance.

▲ Pathways to Independence: Butler County United Way is launching a new initiative in collaboration with the YWCA and Community Behavioral Health. Pathways is designed to bring a comprehensive array of services together to benefit the chronically underemployed and unemployed people of our community and was developed in direct response to the overwhelming survey response identifying unemployment as the most critical issue. The focus of Pathways is simple: jobs and job retention!

▲ Self-Sufficiency: Funding for programs that provide time-limited services that remove barriers to self-sufficiency are covered in the self-sufficiency category. These awards support programs that provide credit counseling, mental health services, medical outreach, financial and family literacy, domestic violence services, and residential programs. The focus of Self-Sufficiency is to reduce dependency on assistance programs.

▲ Basic Services: A new category of funding was developed going forward into 2011 that ensures ongoing funding for programs that meet the basic needs of food and other emergency assistance. Always an area of need addressed by Butler County United Way, the establishment of a separate category underscores the commitment to those most in need.



GRANT CONSORTIUM



Since 2002, the Grant Consortium has assisted in bringing over **15.8 million** new dollars into Butler County and has provided constructive consultation services to Butler County non profit organizations. Services are provided at no charge because of sponsors that support the work and mission of the Grant Consortium. Services include new program initiatives, training and technical assistance and grant proposal development.





The Loyal Donor Program

The Butler County United Way Loyal Donor Program recognizes and celebrates individuals who have supported United Way for ten or more years and, in so doing, have had an impact on the lives of many people in our community. 2010 marked the 90th anniversary of Butler County United Way and in celebration of that we wanted to honor our longest giving donor, Vaden Fitton.

Generational Giving and Loyal Donors . . . a message from Woody Fitton

My father, Vaden Fitton, has supported the Butler County United Way since 1954. He was fortunate to have two very good role models in his parents Don W. and Nanny Fitton. My Grandfather Don was President of First National Bank (predecessor of First Financial Bank) in a career that spanned over 50 years and he was involved in many community initiatives during his career.

Dad learned about playing an active role in community volunteerism and philanthropy from them and I remember as a kid hearing him tell my sisters and me that our family had been very fortunate and that this community had been very good to us. Therefore we had a responsibility and obligation to give back with both our time and resources. He would also say when the opportunity would arise, don't hesitate to take on leadership roles in community organizations and put our money and actions where our mouths are so to speak. He has practiced what he preached.

During his life he has served many community organizations and had much civic involvement:

- United Way Campaign chair from 1973-1975 and Board Member in the 1970's
- Board Chair of YMCA, Fort Hamilton Hospital, Hospice of Miami Valley, New London Hills Swim Club, Hamilton City Club
- Treasurer and fundraising chair for the Hamilton Bicentennial Commission which ultimately funded construction of the Fitton Center and the bike trail along the Miami River
- Served on the Board of Directors for First Financial Bank and Ohio Casualty Corporation
- Served on initial Transportation Improvement District Board
- Board member of YMCA, Fitton Center, Hamilton Community Foundation, Fort Hamilton Hospital, First United Methodist Church

I spent many years in banking and now serve as President of the Greater Miami Valley YMCA. I remain involved in our community in many civic activities as I've learned from the best.



Established in 2005, the FamilyWize Community Service Partnership, joined a group of local and national companies

and organizations together to provide this free assistance to people in need across the country. 95% of the pharmacies nationwide have agreed to provide lower pricing to everyone that brings in a FamilyWize prescription drug discount card. This can help so many people in our community buy the medicine they need to stay healthy.




Butler County United Way joined the FamilyWize program in 2009 and as a result, residents of Butler County have saved over **\$72,559** in prescription drug costs. The discount cards are available through our website, our office and our agencies. Butler County United Way is committed to helping FamilyWize meet its goal of reducing the cost of medicine by \$1 Billion, by 2015, for people struggling to get the medicine they need.



For the past four years, Butler County United Way has partnered with the Butler County Earned Income Tax Project as one of its nine free tax preparation sites located throughout the county.



This free tax service is available to low and moderate income residents of Butler County. IRS-certified volunteers prepare tax returns at no cost and file them electronically, so the tax filer can receive a quick refund. Under the leadership of Legal Aid Society of Southwest Ohio, the refunded dollars for its 1,300 plus tax filers totaled over **\$2 million** during the 2010 tax season. The cost savings for its tax filers, who may have otherwise paid commercial tax preparers to prepare their taxes or who may have received a refund anticipation loan, exceeded \$280,000.

Prior to contracting the service to the Greater Cincinnati United Way call center, Butler County United Way fielded more than 11,000 calls for help during the calendar year of 2010.




YOUTH ASSET EVENT
