Whether you are just beginning to explore grants or have been doing this work for years, I am excited to work with you as part of Butler County's nonprofit community. Grant Link exists to support you not just in identifying funding opportunities, but in navigating a grant environment that continues to change and grow more complex.

One thing I encourage every organization to do is use your grant calendar thoughtfully. The reality is that the grant climate looks different than it did even a few years ago. Many longtime, familiar funders are narrowing their geographic focus or tightening their funding priorities. That can feel discouraging, especially for organizations that have relied on those relationships in the past. But it is also a signal to pause, reassess, and be intentional about where you invest your time and energy.

That shift is also why diversifying funding sources matters more than ever. Depending too heavily on a small number of "go-to" funders puts organizations at risk. Exploring new opportunities, building relationships with a broader mix of funders, and staying open to different types of grants can create more stability over time. Grant Link is here to help you think through that strategy, so your funding plan supports both your mission and your long-term sustainability.

As you pursue new opportunities, Letters of Intent, or LOIs, become especially important. An LOI is often your first and only chance to make an impression. A strong LOI clearly explains who you are, what you are requesting, who you serve, and why your work aligns with the funder's priorities. It should be focused, customized, and written with care. When done well, an LOI opens the door to deeper conversations and full proposals.

Grant Link is here to walk alongside you in this work, from planning your grant calendar to strengthening LOIs and expanding your funding mix. Our goal is to help Butler County nonprofits stay ready, competitive, and confident as you pursue resources that support the people and communities you serve.

National Outlook

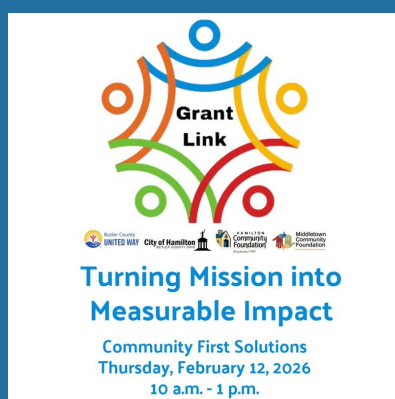
Nationally, the grant and philanthropy landscape continues to evolve in 2026. According to **Foundation Source's 2026 Giving Outlook**, shifts in tax policy, technology, and donor priorities are influencing how private foundations and donor-advised funds distribute grants, underscoring the need for nonprofit leaders to stay adaptable and strategically aligned with funder expectations. While overall charitable giving remains strong, growth has been uneven, with much of the increase concentrated among larger donors and donor-advised funds. As a result, many foundations are choosing to make fewer awards while narrowing their focus on specific outcomes, populations, or geographic impact.

These national trends are showing up locally in very real ways for Butler County nonprofits. Organizations are seeing more funders refine their service-area expectations, asking earlier questions about data and financial health, and looking closely at whether programs are scalable or collaborative. Longtime funding partners remain important, but even familiar funders are adjusting priorities year to year, making renewals less predictable. At the same time, nonprofits serving multiple counties or operating with lean staff are being asked to clearly explain capacity, partnerships, and sustainability earlier in the process.

In this environment, preparation matters. Nonprofits that plan their grant calendars carefully, diversify funding sources, and invest time in strong Letters of Intent and relationship building are better positioned to compete. For Butler County organizations, clarity around impact, readiness, and community connection has become just as essential as passion for the mission itself.
