What is My Free Taxes?

This free Tax Prep Program assists eligible tax filers in filing their taxes online, saving approximately \$250 in tax preparation fees.

The program offers two free filing solutions:

- MyFreeTaxes.com is a free, secure and mobileoptimized website available for families with incomes under \$66,000. It is sponsored by United Way and powered by H & R Block, with a dedicated helpline (1.855.MY.TX. HELP) and online support page.
- Volunteer Income Tax Assistance (VITA) is a free in-person tax filing support for families with incomes under \$54.000. This service is offered by trained and certified volunteers at walk-in or appointment sites throughout Butler County. Additional VITA sites area available outside of Butler County. Why does Butler County United Way want to help individuals file their taxes for free?

We believe in creating a community where everyone has an opportunity to thrive. Free tax preparation is a key initiative in helping families achieve financial stability.

- Free tax preparation helps low and moderate wage workers keep more money in their pockets.
- Tax filing is also required for secondary education supports, marketplace health insurance, home mortgages and eligibility for some public benefits.
- 70% of US tax filers are eligible for free tax preparation, but many don't know it. That includes many employees at partner worksites as well as United Way donors and volunteers!
- Connecting you with this benefit is one more way to give back to our partners, companies and to our donors.

How does MyFreeTaxes. com work?

Sponsored by United Way and powered by H&R Block, anyone earning \$66,000 or less than can file state and federal taxes for free through an easy, safe platform. Filers can start their taxes online and finish them on any device, anywhere. They can even upload tax forms by taking a picture on their phones. Many filers finish their taxes in under an hour.
